BACKGROUND: A change to the description and disposition instructions is necessary to meet current Army requirements. The Army is reducing the retention time for certain records filed under this number. According to the Commander of the U.S. Army Claims Service these records do not need to be kept for 10 years.

Claim investigation reports

Description

Information showing the results of investigation of accidents and incidents which could result in the filing of a claim. Included are investigation reports; marine casualty investigation reports; statements of witnesses, and similar information.

Disposition

a. Reports on possible claims against the Government:

(1) Cases involving medical malpractice: Destroy 10 years after date of incident.

(2) All other cases: Destroy 5 years after date of incident.

b. Reports on possible claims in favor of the Government on which no claim exists: Destroy after

5 years.
