Background Information This is a special purpose system used to transmit and receive Full Motion Video (FMV) and metadata from UAS platforms and other video sensor platforms in a close proximity. Remote Video Viewing Terminal (RVVT) is a mobile video exploitation and management system with integrated receivers and transceivers used to capture and leverage near real-time video and metadata directly from UAS, targeting PODs, intelligence feeds, and other common sensors. RVVT allows Company and below users to view incoming video, as well as archive, annotate, geo-reference and disseminate relevant, actionable video to others across the battlespace for Situational Awareness (SA) and Intelligence, Surveillance, and Reconnaissance (ISR).
